2026 HYUNDAI TUCSON CAR RAFFLE

Instructions for Raffle

1. This raffle is being conducted under 940 CMR 12.00 and M.G. L. c.271, Section 7A, the Massachusetts Code of Regulations that controls the operation of a raffle by a non-profit organization.
2. The organization conducting the raffle is the Angel Fund for ALS Research (Angel Fund, Inc.) located at 649 Main Street, Wakefield, MA 01880. The EIN is 04-3478977. The telephone number is 781-245-7070. The purpose of the raffle is to benefit ALS Research at the University of Massachusetts Chan Medical School. The Angel Fund Chief Development Officer will be the designated member of the organization to be considered the record keeper, responsible for keeping and distributing the raffle tickets. She will be responsible for keeping a list of the organization members, those authorized to sell tickets, all documents related to the raffle, including permits and licenses, and a ledger or record of the tickets. This information will be kept for a period of not less than two years.
3. The following information is being disclosed- The prize is a 2026 Hyundai Tucson Automobile. A complete description of the vehicle and its appraised value is available at TheAngelFund.org. The vehicle is available for inspection at Autofair Hyundai, 1477 S Willow Street, Manchester, NH 03103 during business hours. The value of the vehicle is \$33,165.
4. **The cost of a ticket is \$100.00.** Tickets may be purchased and paid for online by credit card. at TheAngelFund.org. Tickets may not be bartered. **To purchase a ticket, a buyer must 18 years and older, provide their name, address, email and telephone number.** All online ticket sales shall be by the internet at the www.TheAngelFund.org. All e-mail communications will be sent to the e-mail address provided by a purchaser as part of the

purchase. Such communications shall include purchase confirmation and raffle ticket number. The buyer must also sign a disclosure they acknowledge the value of the prize will be considered ordinary income for both federal and state taxes purposes to the winner, and that the winner is responsible for all taxes and fees. The winner may be required to prepay a portion of the tax liability prior to receiving the prize. No portion of the raffle ticket purchase price will qualify as a charitable contribution for tax purposes. This information is being distributed to the purchaser of the raffle tickets at the time of sale. If there are any changes in the terms of the raffle, ticket holders will be notified by mail. Each ticket will have two parts, one of which is retained by the purchaser and the other the record keeper. The tickets shall have sequential serial numbers and shall have the signature of the seller and buyer. Online ticket sales will end on June 20, 2026 at 11:30 pm.

5. The prize will be selected by random chance from those that purchase a raffle ticket. The drawing will be held on Sunday, June 21st at noon at the lower common in Wakefield MA.
6. The maximum number of tickets to be sold is 975. In the event that less than 600 tickets are sold then the Angel Fund will issue refunds for the tickets purchased through their office at the address listed above within 30 days of the proposed drawing date.
7. The winner of the raffle may elect the vehicle or a cash prize of \$15,000. A 1099 will be issued to the winner.
8. No tickets or other materials connected to the raffle may be deposited in the federal mail as it is violation of federal law. No tickets may be sent as a solicitation or offer the purchase by mail to prior ticket purchasers.
9. No member, immediate family member, employee, or immediate family member of an employee of a sponsoring organization who is or has been involved in the promotion of or operation of the raffle shall be permitted to purchase raffle tickets or win the prize. Sale of tickets alone shall not constitute the “promotion and sale of a raffle”. No member of the organization shall receive any remuneration for time or effort devoted to the promotion or operation of the raffle.
10. The organization, Angel Fund, Inc. has obtained the necessary permits to conduct a raffle.
